The Louisiana Housing Council of NAHRO Professional Development Committee is now offering The Nelrod Company COVID-19 Waivers Updates Training. This virtual course will be held Tuesday, October 26, 2021 from 10:00 AM – 12:00 PM.

The Coronavirus Aid, Relief, and Economic Security (CARES) Act provided HUD the authority to waive numerous statutory and regulatory requirements for the public housing program, providing administrative and operational relief in response to the COVID-19 pandemic. Did your agency adopt any of these discretionary waivers? How are they working and what's their current status? Participants in this "live" online micro-course will learn the provisions of the original waivers, how to implement them, and when they're currently set to expire. A checklist will be provided to help prepare your agency for compliance with the expiration dates and to meet deadlines for previously waived tasks which now must be completed.
