The Louisiana Housing Council of NAHRO Professional Development Committee is now offering The Nelrod Company Capital Fund Program Training. This virtual course will be held Tuesday, November 16, 2021 – Wednesday, November 17, 2021 from 9:00 AM – 4:00 PM with optional Certification Exam.

This "live" online training course is designed to help public housing authorities (PHAs) understand the requirements of the Capital Fund Program. Training includes practical information and instruction regarding the implementation of the Public Housing Capital Fund Program Final Rule and the most recent HUD guidance.

Topics covered include:

- Eligible and Ineligible Activities and Cost Limits
- Decoupling of the Capital Fund from the PHA Plan Submission
- Replacement Housing Factor Grants (RHF) and Demolition and Disposition Transitional Funding (DDTF)
- Changes in Obligation and Expenditure End Dates and Close-out Requirements
- Emergency, Non-Presidentially Declared Natural Disaster, and Safety and Security Grant Program Requirements
- Streamlined Mixed-Finance, and other Public Housing Modernization and Development Requirements
- Changes to Demonstration Programs, such as RAD and MTW
- Capital Fund Rule Impact on Security Interests and Financing Activities
