## HANO CELEBRATES THE GRAND OPENING OF THE GUSTE III APARTMENT HOMES



Guste III Apartment Homes

HANO continues to reach milestones in creating more affordable housing opportunities for low income residents in New Orleans. In April, the agency commemorated the completion of the third phase of redevelopment in the Guste Homes Community with a grand opening ceremony for the multi-family building and single family homes.

Visitors ranging from elected officials, community leaders, housing advocates and current and former Guste residents enjoyed the sounds of the James Andrews band while touring eight available apartments, the multi-family community room and highly technical security room, and two of the single family homes.

Construction of phase III began in 2013 at a cost of \$61 million, through the use of \$26 million from HANO, \$21.9 million from FEMA, and \$13.1 million in Low Income Housing Tax Credits. Gibbs Construction and Colmex Construction completed the development of 155 new one, two, three and four bedroom units, which include Energy Star appliances, and are also pre-wired for cable and internet services. Community supportive services provided by the Guste Resident Management Corporation are available for residents living in the community.

The William J. Guste Homes community was originally built in 1964 with 993 public housing units. The initial site consisted of one 12-story high-rise, elderly-only building and six low-rise buildings. In 2004, HANO began its full redevelopment following approval of a conversion plan by HUD and the subsequent demolition of the low-rise buildings through the use of a HOPE VI Grant. Currently, there are 638 homes located on the entire Guste site; 577 of which are public housing units.

## LEESVILLE HOUSING AUTHORITY BRINGS NEW LIFE TO THE TWIN LAKES OF LEESVILLE HOUSING DEVELOPMENT

The Leesville Housing Authority (LHA) led by Executive Director, Barbara Kaveski, partnered with BGC to transform their aging public properties into a vibrant and sustainable affordable housing community. The result was the first RAD portfolio conversion in Louisiana and it was the first project in the country to receive a RAD PBV Utility Waiver. All was made possible by securing a complex layering of critical funding totaling \$23,433,133 from multiple sources, including: Enterprise Community Partners, Bellwether Enterprise (RD 538 Loan), PHA funds, Louisiana Housing Corporation HOME Funds, and Tax-Exempt Bonds.

Twin Lakes of Leesville is now a four-site development with 194 units. The 14-month renovation includes thoughtful interior updates, such as new windows, floors, lighting, cabinets, fresh paint, and electrical panels, as well as exterior upgrades, including replacing major building systems, repaving roads, and installing new signage, gas lines, and meters. Some units were optimized to meet ADA requirements for handicapped or disabled tenants, but every unit received a unique face-lift. As originally built, the buildings were boxy with no unique or special architectural details. Now, they are re-imagined and dignified with stone bases and battens on the siding.

No detail was overlooked. Great care was taken to provide improved interior amenities, including in-unit energy

efficient kitchen appliances and washers and dryers, ceiling fans, and digitally controlled heating and air. Exteriors were finished with lush landscaping. LHA organized volunteers, community members, and residents for a Beautification Day with BGC Advantage. Volunteers, young and old, helped plant, trim, and mulch all four sites. Finally, as an inviting beacon to the new family-focused development, the main office was leveled to make way for a modern facility with handicapped accessibility and welcoming spaces for meetings.

"Working with Barbara Kaveski has been a joy. She was a true partner in every sense of the word, working tirelessly to ensure the residents were a top priority," said BGC Advantage CEO Holly Knight. "From concept to completion, her vision and creativity helped us realize the full potential of this project."

"Our agency could have not reached our current level of achievement without BGC Advantage providing us with the tools and resources to continue our vision of providing affordable housing in our community," said Leesville Housing Authority of CEO Barbara Kaveski. "Holly and BGC Advantage motivated our agency to push through every challenge with unwavering determination. Uniform Physical Condition Standards (UPCS) Seminar

In an effort to continue to provide quality and affordable training opportunities to public housing authorities across the country, the Housing Authority of the City of Shreveport recently hosted two professional development trainings.

Last month, NAHRO instructor Kenneth Love presented a three-day Uniform Physical Condition Standards (UPCS) seminar. The interactive and comprehensive training focused on the specifications of public housing assessment systems, the inspector's role and responsibilities, and discussing any new challenges and procedures in relation to the Uniform Physical Condition Standards (UPCS). Over a dozen participants from five states attended the training opportunity.

On May 1st to 4th, the Housing Authority also hosted the "Back to Basics: HUD Accounting for Public Housing and the Housing Choice Voucher Program" training presented by Mike Petro and Jason Casterline of BDO USA, LLP. This innovative course provided participants with a comprehensive overview of the Low Income Public Housing, Section 8, and the RAD program's accounting and reporting activities.
